Sub: Application under RTI Act 2005 on fixation of rates of Textiles – Reg.

This has reference to your letter dated 30.10.2017 submitted under RTI Act 2005. In this regard, it is to mention that Central.Silk Board is an R&D Institution looking after the overall development of the Sericulture Sector in the country and is not involved in fixing of prices of silk commodities. Keeping in your query, the following reply is furnished:

- 1) In India who will fix the rates of Textiles  
Reply: Usually it is market, which decides the prices of silk goods based on many factors such as demand, supply, cost of inputs, reasonable profit margin etc.
- 2) Prices of Textiles are increasing continuously who are responsible for this? Ministers or Officers  
Reply: It may kindly be noted that the increase in the prices of textiles largely depends on the demand and supply of the silk goods/items. Ministers or Officers concerned have no role to play in the matter.
- 3) How the process of fixation of prices is doing? Keeping in view the position of poor people or Benefit of rich people  
Reply: There are no specific standards for fixation of prices of silk textile items. Further fixation of prices has nothing to do with position of poor people or Benefit of the rich people
- 4) When fixation of prices of textiles by big Textile Merchants/Owners of Textile factories from whom orders/instructions would be taken by them? From Officers or Ministers? What are the norms for this?  
Reply: As informed under Point No. 2 the Ministers or Officers have no role to play in fixation of the prices
- 5) Is Textiles Ministry have any rules/Codes/Guidelines regarding fixation of prices of Textiles? If so, Please give its details/information.  
Reply: Central Silk Board does not make any rule or guidelines for fixation of the prices since the commodities and their prices are market driven.
