I have joined on 23.05.1983 and the senior most Scientist-D under ZSSO Dehradun (U.K.) zone. Kindly clarify and provide me the following information as under-

1. Can a junior Scientist-D (Dr. V. P. Gupta, Scientist-D Cold Storage Plant Dehradun) draw senior's monthly salary? It will be humiliation by administration.
2. Can a junior Scientist-D (Dr. Abad A. Siddiqui, Scientist-D ZSSO Dehradun) make any entry in senior's Service Book or Annual Confidential Report or AWPR or give Instruction etc? It seems deformation of administration.
3. If so above happen! Under which administrative rule and regulation the above said status / action being enforced.
4. The Director NSSO office letter NO.CSB/NSSO/3 (2646)/17-ES dated 18.07.2017 is in order or not?
5. Kindly make an amicable status under fair administration please.
