Sir,

It is fact that Shri R.Eshwara had been working in the office of NSSO, Central Silk Board, CSB Complex, Hosur Road, Madiwala, Bangalore- 560 068 with the capacity of Dy. Director. He approached the judicial authority for his promotion to the post of Jt. Director as the post was lying vacant. Hon'ble High Court of Bangalore had passed the order in favour of Shri R.Eshwara. Resultantly, your office had promoted him to the post of Jt. Director and his pay was fixed accordingly. Now I request you to provide the following information under RTI Act, 2005:

1. Copy of the Order of promotion in r/o Shri R.Eshwara to the post of Jt. Director in Central Silk Board.
2. Copy of the Pay fixation order in r/o Shri R.Eshwara to the post of Jt. Director in Central Silk Board.
3. Copy of the order of Hon'ble High Court of Bangalore on the basis of which promotion had been awarded to Shri R.Eshwara to the post of Jt. Director.
4. Copy of the representation made by Shri R.Eshwara for his promotion to the post of Jt. Director in compliance of the Court Order.
5. Copy of the Note Sheet in which the representation, in question, made by Shri R.Eshwara after the Hon'ble Court passed order in his favour was put up and approved by the competent authority for awarding him promotion to the post of Jt. Director.
6. Action taken Note for giving consequential effect for awarding promotion to the post of Dy. Director from its Feeder Category after the post of Dy. Director had become vacant subsequent upon promotion of Shri R.Eshwara to the post of Jt. Director.

The above information cannot be denied on the ground of classified documents nor that of third party information since it is in public domain and govt. exchequer is involved here. A copy of my Aadhar Card is enclosed herewith for convenience.
