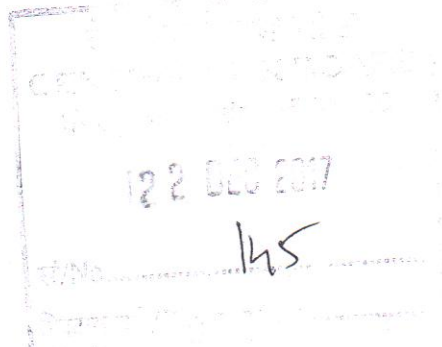
Sub:- Information sought under RTI Act, 2005

Sir,

I would like to refer to your letter No. CSB-6(1)/2004-ES-II (Law) dated 08.11.2017 issued to the undersigned in response to my RTI application dated 17.10.2017. You have informed that CSB vide its order No. CSB-6(1)/2004-ES-II dated 03.11.2017 has granted the designation of Joint Director (Admn.) to Shri R.Eswara, Deputy Director (Adm. & Accts.) (Retired) on the recommendation of the DPC held on 17.03.2012 and orders of the competent authority. In view of this, I seek the following information u/s 6(1) read with 6(2) of the RTI Act, 2005:

- 1) Certified copy of the minutes of the DPC held on 17.03.2012 for consideration of the promotion to the post of Joint Director (Adm.) and all related documents in connection with the DPC, in question, held on 17.3.2012.
- 2) Certified copy of the minutes of the DPC held in 2012 for consideration of the resultant promotion to the post of Deputy Director (Adm. & Accts.) consequent upon the said post which was about to become vacant and supposed to be filled up due to likely promotion of Sh. R.Eswara, Deputy Director (Adm. & Accts.) to the post of Joint Director (Adm.) on the basis of the recommendation of DPC held on 17.3.2012.
- 3) From the Order No. CSB/NSSO/3(1579)/WB/93-ES/3868 dated 03.08.2017 emanated from National Silkworm Seed Organization, it is found that Pay of Shri R.Eswara has been fixed in the Grade Pay of Rs. 7600/- (Pre-revised VI CPC) w.e.f. 01.12.2012. It sufficiently emerges that the Post of Deputy Director (Adm. & Accts.) had also become vacant w.e.f. 01.12.2012 which was to be filled up by its feeder category w.e.f. 01.12.2012 itself by the then eligible incumbent. Now, I may kindly be provided a **certified** copy of the Action Taken Note (ATN) for filling up the post of Deputy Director (Adm. & Accts.) w.e.f. **01.12.2012** by the then eligible officer/ incumbent available in the feeder Category of that very post i.e. Deputy Director (Adm. & Accts.), which became vacant w.e.f. **01.12.2012** on account of promotion of Shri R.Eswara to the post of Joint Director (Admn).

- 4) Name of the senior most eligible officer/ incumbent, who was holding the post of Assistant Director (Admn & Accts) as on 30.11.2012 in Central Silk Board and attained a legitimate right for promotion to the post of Dy. Director (Admn & Accts) which was vacant consequent upon the promotion of Sh. R. Eswara, the then Dy. Director (Admn & Accts) to the post of Joint Director (Admn) w.e.f. 01.12.2012.
- 5) Name of the incumbent who was granted promotion to the post of Dy. Director (Admn. & Accts) which has been filled up immediately after Sh. R. Eswara vacated this post on his promotion to the post of Joint Director (Admn) and the date when from the promotion was made effective to the resultant vacant post of Dy. Director (Admn. & Accts).
- 6) If the post of Dy. Director (Admn. & Accts) in CSB is not filled up retrospectively w.e.f. 01.12.2012, then **certified copy** of the documents, where the reasons so recorded for not filling up the post granting promotion to the then most eligible Assistant Director w.e.f. 01.12.2012, may kindly be provided.

I am enclosing herewith an IPO of Rs. 10/- having No. 43F 207669 as the RTI application fee and another IPO of Rs. 50/- having No. 89G 385015 @ Rs. 2/- per page as charges of the required documents sought above.
