CIRCULAR

It has been observed by the undersigned that frequent tours taken by the Directors of Central Silk Board is hampering the R & D works. Although it is necessary that the Directors have to undertake tours, it is inevitable in the interest of R & D work that they go on tour only when it is absolutely necessary and their participation is fully justified. Hence, all the Directors of the Research Institutes are hereby advised to obtain prior approval of the undersigned at least 20 days before they initiate such tours. Further, if it is felt that their tour is very essential, they need to justify it.

It is also noticed that sufficient time for interaction with the farmers is not slotted for Farmers' Meet / Melas. All the Directors are also hereby advised to ensure that sufficient time is devoted for meaningful interactions with the farmers whenever the Krishi Melas / Meets and other Extension Communication Programmes (ECPs) are conducted. The scientists should make it a point to ensure that the need based technologies are conveyed to all the farmers in a convincing manner in order to improve the quality, production and productivity of silk.
