CIRCULAR

Sub: Filling up of the posts of Field Assistant – Amendment to Recruitment Rules – regarding.

== ** ==

Central Silk Board had released an Advertisement No. CSB/2/2014 in the Employment News of 15-21 February, 2014 issue inviting applications for filling up of 229 posts in various categories which included **112 posts of Field Assistant**. As per the advertisement released in compliance to the then existing Central Silk Board (Consolidated) Recruitment Rules, 1989, there was no provision for age-relaxation and service weightage for the Skilled Farm Workers of CSB. Though, many of the Skilled Farm Workers were educationally qualified, they could not apply as they were over-aged. Aggrieved by this, Shri Mariswamy, CSB Skilled Farm Worker and 11 others approached the Hon'ble Central Administrative Tribunal, Bangalore Bench, Bangalore in OA Nos. 424-435/2014. After hearing both the parties, the Hon'ble Central Administrative Tribunal vide its order dated 22nd April, 2014 directed CSB to immediately approach the Union of India with a proposal for granting of service weightage and age relaxation for in-service candidates. In obedience thereof, CSB submitted a proposal to the Administrative Ministry. The said amendment has been notified by the Ministry of Textiles in the 'Gazette of India' of 13th March, 2015 according to which

“Central Silk Board employees working in the cadres of Assistant Technician, Attender, Chowkidar, Safaiwala and Skilled Farm Workers possessing the prescribed educational qualification are eligible to apply. The service rendered by them as Casual Labourer, Time Scale Farm Worker / Skilled Farm Worker and Group-D employees in the Central Silk Board shall also be counted for the purpose of age relaxation”.

All the eligible departmental candidates working in the cadres of Assistant Technician/ Attender/ Chowkidar/ Safaiwala and Skilled Farm Workers who possess the educational qualification for the post (details posted on the official website www.csb.gov.in) may apply for the post of Field Assistant. They are entitled for relaxation of the age limit to the extent of service rendered by them as Casual Labour, Time Scale Farm Worker / Skilled Farm Worker or as Group-D employee.

They may submit their **applications directly to this office so as to reach the Member Secretary, Central Silk Board, CSB Complex, B.T.M. Layout, Madivala, Hosur Road, Bangalore – 560 068 on or before 30th April, 2015.**

Applications which are unsigned or not in the prescribed format or without photocopies of all certificates relating to date of birth, educational qualification and experience (including caste certificate in respect of SC/ST/OBC candidates and medical certificates in respect of Persons With Disabilities) in support of their claim or applications received after the last date stipulated in this circular shall be summarily rejected. OBC certificates issued by the Competent Authority in the prescribed proforma "FORM OF CERTIFICATE TO BE PRODUCED BY OTHER BACKWARD CLASSES APPLYING FOR APPOINTMENT TO POSTS UNDER THE GOVERNMENT OF INDIA" only will be accepted.

AGE LIMIT & RELAXATIONS:

Note:

Central Silk Board employees working in the cadres of **Assistant Technician, Attender, Chowkidar, Safaiwala** and **Skilled Farm Workers** possessing the prescribed educational qualification are eligible to apply and the service rendered by them as Casual Labourer, Time Scale Farm Worker / Skilled Farm Worker and Group-D employees in the Central Silk Board shall be counted for the purpose of age relaxation”.

In addition to the above, the **Assistant Technicians, Attenders, Chowkidars, Safaiwalas** and **Skilled Farm Workers** are eligible for the following relaxations:

- The date for determining the upper age limit, qualifications and experience shall be the closing date prescribed for receipt of completed application as indicated above **ie. 30th April, 2015.**
- The age limit shown for the post is normal age limit as per Recruitment Rules. However, age is relaxable for SC/ST candidates upto 5 years and upto 3 years for OBC candidates in respect of vacancies reserved for them.
- Persons with Disabilities are eligible for 10 years age relaxation over and above the upper age limit as per Govt. of India Rules.
- Relaxation of 5 years will also be permissible to those who had ordinarily been domiciled in the State of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989 subject to production of relevant certificate from concerned authority.
