
Sub: Filling up of posts of Field Assistant in the Pay Band-1
Rs.5200-20200 + G.P.of Rs.2000/- under Central Silk Board – reg.

It is informed that an advertisement inviting applications for filling up of 229 various posts which included 112 posts of Field Assistant was released in the Employment News during February, 2014. Aggrieved by the fact that Farm Workers of the CSB had not been provided age-relaxation and service weightage, some Farm Workers of CSB filed an OA before the Hon'ble Central Administrative Tribunal seeking direction to CSB to consider their cases also. As per the directions of Hon'ble CAT., Bangalore Bench, Bangalore, Recruitment Rules for the post of Field Assistant have been amended and opportunity has been given to eligible Farm Workers to submit their applications.

Some of the eligible Skilled Farm Workers have submitted their applications and interview call letters have been issued to them. The Skilled Farm Workers who have been issued call letters have been advised to bring with them documentary evidence in support of their educational qualifications, age, experience, caste(in the case of SC/ST/OBC only), Medical Certificate issued by Medical Board in respect of candidates belonging to Persons with Disabilities category etc., in original for verification. In addition to the above, these Skilled Farm Workers have been provided with a blank format by Central Office, Bangalore, with advice to get the format duly completed in all respects and attested by the In-charge Officer of the concerned CSB Unit where his service records are maintained. It has also been indicated in the call letter that the Skilled Farm Workers who do not bring the above proforma duly completed and signed by the in-charge Officers will not be permitted to attend the interview.

In view of the above, all the in-charge Officers of CSB Units are requested to issue the certificates in the prescribed format (copy enclosed) on request from the concerned Skilled Farm Workers for the purpose of producing the same in original at the time of interview.
