Central Silk Board (CSB) is a Statutory body established in 1948 by an Act of Parliament. It is working under the administrative control of Ministry of Textiles, Government of India.

The Central Silk Board is the **apex national organization** responsible for the overall development of the **silk sector in India**, covering the entire value chain from **research and development, seed production, extension, quality certification, training, technology transfer, and policy support** in both **pre-cocoon and post-cocoon sectors**.

CSB operates through a network of **Research Institutes, Regional Offices, Seed Organizations, Training Centres and Field Units** spread across various silk-producing States and Union Territories. The Board plays a pivotal role in supporting State Governments, farmers, reelers, weavers and entrepreneurs by providing **scientific, technical and advisory services** for sustainable growth of the silk industry.

In view of the **mandated functions and time-bound operational requirements**, the Central Silk Board, from time to time, engages **technical and supporting manpower on a contractual basis** to meet urgent and essential needs. Such engagements are **purely temporary and contractual**, intended to ensure continuity of critical activities, and **do not constitute regular employment** under the Government of India.

5. The selected individuals will not be associated with any specific project, but will instead assist in the work performed by Senior Technical Assistants at the CSB Institutes/Units.
6. Number of vacancies mentioned above, may increase or decrease depending upon the requirement of the Board.
7. The Central Silk Board has full right to cancel / modify the above engagement in complete or for a particular post(s), without giving any reasons.
8. The selection to the above contractual posts will be done, based on the performance of eligible candidates in the personal interview, only.
9. The date, time and venue of Personal Interview will be intimated to the eligible candidates through e-mail only. The candidates are advised to use correct / working E-mail ID in the application form.
